confirms the right to use the waters of TWO SUMP WELLS, tributary to COLUMBIA RIVER, for MUNICIPAL USES.

This right was perfected under Permit G-8619. The date of priority is June 4, 1979. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 2.26 CUBIC FEET PER SECOND (CFS); BEING 1.84 CFS FROM SUMP WELL #1 AND 1.95 CFS FROM SUMP WELL #2 IN ANY COMBINATION; FURTHER LIMITED TO NOT TO EXCEED 1632.6 ACRE-FEET PER YEAR, or its equivalent in case of rotation, measured at the well.

The sump wells are located as follows:

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

THE PORT OF MORROW SERVICE AREA NEAR BOARDMAN, OREGON

When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Water shall be acquired from the same aquifer as the original point of appropriation.

This certificate is issued to confirm a change in PLACE OF USE AND CHARACTER OF USE approved by an order of the Water Resources Director entered JANUARY 5, 1994, at Special Order Volume 48, Page 36, approving Transfer Application 6966, and supercedes Certificate 51782, State record of Water Right Certificates.
