CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of TWO WELLS in the PUDDING RIVER BASIN, for IRRIGATION of 145.55 ACRES.

This right was perfected under Permit G-6667. The date of priority is JULY 1, 1974. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.64 CUBIC FOOT PER SECOND (IF AVAILABLE AT THE ORIGINAL POINT OF APPROPRIATION BEING LOCATED WITHIN THE SW1/4 NE1/4, AS PROJECTED WITHIN W. RUSSELL DLC 41, SECTION 30, TOWNSHIP 6 SOUTH, RANGE 1 WEST, W.M.; 1870 FEET SOUTH AND 1460 FEET WEST FROM THE NE CORNER OF W. RUSSELL DLC 41), or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Water shall be acquired from the same aquifer (water source) as the original point of appropriation, being the alluvial aquifer only. Water may <u>not</u> be acquired from any basalt aquifers.

The quantity of water diverted at the additional point of appropriation, together with that diverted at the original point of appropriation, shall not exceed the quantity of water lawfully available at the original point of appropriation.

The water user shall maintain an in-line flow meter or other suitable device for measuring and recording the quantity of water appropriated.

The wells shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm AN ADDITIONAL POINT OF APPROPRIATION approved by an order of the Water Resources Director entered SEPTEMBER 7, 2006, at Special Order Volume 70, Page 173, approving Transfer Application 10118, supercedes Certificate 80586, State record of Water Right Certificates.
