## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of SYCAN RIVER for IRRIGATION of 47.6 ACRES.

This right was perfected under Permit S-46826. The date of priority is MAY 10, 1982. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.19 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year.

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate within three months after issuance of the certificate.
