CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

PINE MEADOW RANCH INC.

SISTERS OR 97759

confirms the right to use the waters of SQUAW [WHYCHUS] CREEK, tributary to DESCHUTES RIVER, for IRRIGATION of 53.7 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Crook County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 1, Page 120. The date of priority thereby confirmed is 1886.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.75 CUBIC FOOT PER SECOND. The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of 1/72 of one cubic foot per second, or its equivalent for each acre irrigated.

The point of diversion is located as follows:

A description of the place of use is as follows:

Measurement, recording and reporting conditions:

- A. The water user shall maintain the meter or other suitable measuring device in good working order.
- B. The water user shall allow the watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the watermaster shall request access upon reasonable notice.

The quantity of water diverted at the new point of diversion shall not exceed the quantity of water lawfully available from the original point of diversion.

The right to the use of the water for the above purpose is restricted to beneficial use on place of use described, and is subject to all other conditions and limitations contained in said decree.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm the finalization of allocation of conserved water application CW-82 in an order of the Water Resources Director entered June 12, 2014 at Special Order Volume 92, Page 793, Final Order on Finalization of Allocation of Conserved Water Application CW-82 and changing the point of diversion, and together with Certificates 89347, supersedes Certificate 293, State Record of Water Right Certificates.
