CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RICK A. HUFSTADER AND CYNTHIA STRICKLAND

confirms the right to use the waters of JOHN DAY RIVER, a tributary of COLUMBIA RIVER, for IRRIGATION of 8.3 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Grant County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 15, at Page 461. The date of priority is 1906.

The amount of water to which this right is entitled is limited to an amount actually used beneficially for said purposes and shall not exceed ONE-FORTIETH of one cubic foot per second per acre irrigated from April 1 to September 30, further limited to ONE ACRE-FOOT per acre per calendar month to July 1 and 3/4 ACRE-FOOT PER ACRE thereafter, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed FIVE acre-feet for each acre per season, measured at the point of diversion.

The point of diversion is located as follows:

A description of the place of use is as follows:

The quantity of water diverted at the new point of diversion shall not exceed the quantity of water lawfully available from the original point of diversion described as follows:

13 S	29 E	WM	27	NW NE	50 FEET SOUTH AND 3380 FEET EAST FROM NW CORNER, SECTION 27

The water user shall maintain the meter or other suitable measuring device in good working order at each point of diversion.

When required by the Department, the water user shall install, maintain and operate a headgate to control and regulate the quantity of water diverted. The type and plans of the headgate must be approved by the Department prior to beginning of construction and shall be installed under the general supervision of the Department.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW


This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The water user shall maintain and operate the fish screen and/or by-pass device, as appropriate, at the point of diversion consistent with the Oregon Department of Fish and Wildlife's operational and maintenance standards.

The right to the use of the water for the above purpose is restricted to beneficial use on place of use described, and is subject to all other conditions and limitations contained in said decree.

This certificate is issued to confirm changes in point of diversion and place of use approved by an order of the Water Resources Director entered August 27, 2010, at Special Order Volume 81, Page 773, approving Transfer Application 10630, and together with Certificate 86540, supercedes Certificate 39357, State record of Water Right Certificates.
