CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of WOOD CREEK, a tributary of WINDY CREEK, for IRRIGATION of 4.2 ACRES AND STOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for DOUGLAS County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 11, at Page 1. The date of priority is 1894.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed the rate of one cubic foot of water per second of time for each 70 acres of land irrigated during the irrigation season.

The point of diversion is located as follows:

A description of the place of use is as follows:

The quantity of water diverted at the new point of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water lawfully available at the original point of diversion.

The water user shall maintain headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.

Water user shall be acquired from the same surface water sources as the original point of diversion.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The water user shall maintain a fish screen or fish by-pass device.

The right to the use of the water for the above purpose is restricted to beneficial use on place of use described, and is subject to all other conditions and limitations contained in said decree.

This certificate is issued to confirm a change in PLACE OF USE, POINT OF DIVERSION AND PARTIAL CANCELLATION OF A WATER RIGHT approved by an order of the Water Resources Director entered August 27, 2002, at Special Order Volume 56, Page 903, approving Transfer Application 8895, and together with Certificate 79574, supercedes Certificate 9687, State Record of Water Right Certificates.
