CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ROCK CREEK WATER DISTRICT

confirms the right to use the waters of UNNAMED STREAM and ROCK CREEK HIDEOUT RESERVOIR, CONSTRUCTED UNDER PERMIT R-4872, a tributary of ROCK CREEK, for MUNICIPAL USE.

This right was perfected under Permit S-32029. The date of priority is SEPTEMBER 26, 1966. The right is limited to not more than 0.14 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described; however, water may be applied to lands which are not specifically described above, provided the holder of this right complies with ORS 540.510(3).

This certificate is issued to confirm a CHANGE IN CHARACTER OF USE approved by an order of the Water Resources Director entered SEPTEMBER 18, 2000, at Special Order Volume 54, Page 714, approving Transfer Application 8473, and supersedes Certificate 61769, State Record of Water Right Certificates.
