CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WIGRICH FARM, INC. 5835 WIGRICH RD. INDEPENDENCE, OR 97351

confirms the right to use the waters of the WILLAMETTE RIVER, a tributary to the COLUMBIA RIVER for SUPPLEMENTAL IRRIGATION of 125.4 ACRES.

This right was perfected under Permit S-33775. The date of priority is JULY 24, 1968. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.57 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the points of diversion from the source.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acrefeet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
