	of record in the Record of Proceedings of said Board, at Salem, in Volume 1,
	at page 191 , on the 1st day of September, 1915 ; that the priority of
	the right hereby confirmed dates from May 12, 1911 ; that the amount of
	water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not
	exceed 10.25 cubic feet per second.
	A description of the lands under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows:
	8 acres in the Southeast quarter of Northwest quarter and 12 acres
	in the Northeast quarter of Northwest quarter of Section Twenty-six (26), Township Five (5) North, Range Thirty-five (35) East of Willamette Meridian, in Umatilla County, Oregon.
	The appropriation for irrigation purposes is hereby limited to 0.25
	cubic foot per second, or its equivalent in case of rotation; balance of appropriation for power purposes.
	The use for irrigation purposes shall conform to any reasonable rotations ordered by the proper State Officer. The right to the use of the water aforesaid hereby confirmed is restricted to the
	lands or place of use herein described.
	Rights to the use of water for power purposes are limited to a period of forty years from the date of priority of the right, as herein set forth, subject to a preference right of renewal under the laws existing at the date of the expiration of the right for power purposes, as hereby confirmed and limited.
