CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CRUM RANCHES LLC PO BOX 121 IONE OR 97843

confirms the right to use the waters of THREE WELLS in the WILLOW CREEK BASIN, for IRRIGATION of 716.3 ACRES.

This right was perfected under Permit G-4160. The date of priority is May 29, 1968. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 4.0 cubic feet per second (cfs), being 2.68 cfs from Well No. 3 and 4.0 cfs each from Well No. 5 and Well No. 6 provided that the quantity appropriated from the wells shall not exceed 4.0 cfs or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
