 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WAYNE O. AND NANCY K. DOLLARHIDE

 GRANTS PASS, OR 97527

confirms the right to use the waters of ALTHOUSE CREEK, tributary to the ILLINOIS RIVER, for IRRIGATION of 33.3 ACRES; BEING 30.4 ACRES WITH 1870 PRIORITY DATE AND 2.9 ACRES WITH 1856 PRIORITY DATE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Josephine County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 4, at Page 427. The dates of priority are 1856 and 1870.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.67 CUBIC FOOT PER SECOND (CFS); BEING 0.61 CFS WITH 1870 PRIORITY DATE AND 0.06 CFS WITH 1856 PRIORITY DATE, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.

The water user shall maintain a fish screen or fish by-pass device, as appropriate, at the point of diversion.

The right to the use of the water for the above purpose is restricted to beneficial use on place of use described, and is subject to all other conditions and limitations contained in said decree.

This certificate is issued to confirm an ADDITIONAL POINT OF DIVERSION approved by an order of the Water Resources Director entered February 17, 2005, at Special Order Volume 63, Page 334, approving Transfer Application 9724, superseded by an order entered September 1, 2009, at Special Order Volume 78, Page 821, and together with Certificate 81141, supersedes Certificate 53632, State Record of Water Right Certificates.
