confirms the right to use the waters of ALTHOUSE CREEK, tributary of the ILLINOIS RIVER, for IRRIGATION of 89.5 ACRES, DOMESTIC and STOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Josephine County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 4, at Page 427. The date of priority is 1856.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.79 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.
