confirms the right to use the waters of RODERICK CREEK, tributary of GALES CREEK for IRRIGATION of 0.7 ACRE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Washington County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 16, at Page 419. The date of priority is 1880.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.0175 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation of WASABI (JAPANESE HORSERADISH), together with the amount secured under any other right existing for the same lands, is limited to the amount actually beneficially used and shall not exceed ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 5 acre-feet for each acre irrigated during the irrigation season, May 1 to September 30, of each year. For the irrigation of any other crop, ONE-EIGHTIETH of one cubic foot per second and 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The right to the use of the water for the above purpose is restricted to beneficial use on place of use described, and is subject to all other conditions and limitations contained in said decree.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered March 23, 1999, at Special Order Volume 53, Page 455, approving Transfer Application 7870, and together with Certificate 75468, supersedes Certificate 29250, State Record of Water Right Certificates.
