CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

BILL GRABLE 42997 HANEY LANE PENDLETON OR 97801

confirms the right to use the waters of MCKAY CREEK, tributary to UMATILLA RIVER for DOMESTIC, LIVESTOCK AND IRRIGATION of 2.42 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 3, at Page 127. The date of priority is 1894 for 1.14 acres, and 1907 for 1.28 acres. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.03 CUBIC FOOT PER SECOND (CFS), being 0.014 CFS for 1894 priority and 0.016 CFS for 1907 priority, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, during the irrigation season of each year.

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.

The water user shall maintain a fish screen or fish by-pass device as approved by the Oregon Department of Fish and Wildlife.

Water shall be acquired from the same surface source as the original point of diversion.

The right to the use of the water for the above purpose is restricted to beneficial use on place of use described, and is subject to all other conditions and limitations contained in said decree.

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered March 25, 1998 at Special Order Volume 52, Page 250, approving Transfer Application 7665, and together with Certificate 75552, supercedes Certificate 72441, State record of Water Right Certificates.
