CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of COLD SPRINGS AND A RESERVOIR CONSTRUCTED UNDER APPLICATION R-71775, PERMIT R-11448, TRIBUTARIES OF SQUAW CREEK for SUPPLEMENTAL IRRIGATION of 150.71 ACRES, FISH REARING AND WILDLIFE HABITAT.

This right was perfected under Permit S-51431. The date of priority is JULY 24, 1991. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 63.0 ACRE FEET FROM RESERVOIR FOR SUPPLEMENTAL IRRIGATION AND 0.7 CUBIC FEET PER SECOND FROM COLD SPRINGS FOR MAINTENANCE OF A RESERVOIR FOR FISH REARING AND WILDLIFE HABITAT, or its equivalent in case of rotation, measured at the point of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation under this right is limited to a diversion of 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. This right is a limited to any deficiency in the available supply of any prior right existing for the same land.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484 and ORS 536.075. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 183.484, ORS 536.075 and OAR 137-004-0080, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate within three months after issuance of the certificate.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
