CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of FOUR WELLS within the MALHEUR LAKE BASIN for SUPPLEMENTAL IRRIGATION of 260.6 ACRES.

This right was perfected under Permit U-259. The date of priority is AUGUST 26, 1948. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 3.09 CUBIC FEET PER SECOND (CFS), further limited to 0.87 CFS from Well 1, 0.87 CFS from Well 2, 0.87 CFS from Well 3, and 1.05 CFS from Well 4, or its equivalent in case of rotation, measured at the wells.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
