confirms the right to use the waters of MILL CREEK AND GOODRICH CREEK, tributaries of the POWDER RIVER, for IRRIGATION of 10.0 ACRES AND SUPPLEMENTAL IRRIGATION of 393.36 ACRES.

This right was perfected under Permit S-1713. The date of priority is JULY 28, 1913. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 5.04 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the stream.

The points of diversion are located as follows:

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
A description of the place of use is as follows:

Any petition for judicial review must be filed within the 60 -day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The water user shall maintain headgates, in-line flow meters, weirs, or other suitable devices for measuring and recording the quantity of water diverted.

This right shall be subject to the terms and conditions of the Water Transfer and Ditch Use Agreement record at Special Order Volume 45, Page 512, and by reference made a part hereof.

As a part of the Water transfer and Ditch Use Agreement, this right will not be superior to the other rights using the Bowles Ditch, but equivalent to the 1959 and 1960 water rights.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered June 8, 1995, at Special Order Volume 49, Page 234, approving Transfer Application 5934, and together with Certificate 68501, supercedes Certificate 29805, State record of Water Right Certificates.
