OREGON DEPARTMENT OF FISH AND WILDLIFE 4034 FAIRVIEW INDUSTRIAL DRIVE SE SALEM, OR 97302

confirms the right to use the waters of LADD CREEK, a tributary of CATHERINE CREEK and CATHERINE CREEK, a tributary of the GRANDE RONDE RIVER for WILDLIFE MANAGEMENT.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Union County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 8, at Page 1. The dates of priority are 1868 from Ladd Creek and 1870 from Catherine Creek.

The use of water for Wildlife Management shall be limited to a diversion of not to exceed 369.3 acre-feet from Ladd Creek and 432.3 acre-feet from Catherine Creek in any irrigation season of the year. The use is further limited to a diversion of not to exceed 3.08 cubic feet per second (CFS) from Ladd Creek and 3.60 CFS from Catherine Creek during the irrigation season of each year.
