confirms the right to use the waters of WALLA WALLA RIVER, a tributary of Columbia River, for IRRIGATION of 11.8 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director, in Volume 12 at Page 9. The date of priority is 1893.

The use is limited to one miner's inches per acre, or 0.295 CUBIC FOOT PER SECOND (cfs), or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:
