confirms the right to use the waters of WALLA WALLA RIVER, a tributary of Columbia River, for IRRIGATION of 18.43 ACRES and STOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director, in Volume 12 at Page 9. The date of priority is 1887.

The use is limited to one miner's inches per acre, or 0.461 CUBIC FOOT PER SECOND (cfs), or its equivalent in case of rotation, measured at the point of diversion from the source.
