## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GREG & LISA RUSSELL 84576 EASTSIDE ROAD MILTON FREEWATER, OR 97862

confirms the right to use the waters of WALLA WALLA RIVER, a tributary of Columbia River, for IRRIGATION of 3.0 ACRES and STOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director, in Volume 12 at Page 9. The dates of priority are 1887 and 1905, as further described below.

The use is limited to one miner's inches per acre, or 0.075 CUBIC FOOT PER SECOND (cfs), being 0.05 cfs under the 1887 priority date and 0.025 cfs under the 1905 priority date, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described, and the right shall be subject to all other conditions and limitations contained in the above-described decree.
