confirms the right to use the waters of the WALLA WALLA RIVER, a tributary of Columbia River, for IRRIGATION of 0.40 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director, in Volume 12 at Page 9. The date of priority is 1891.

The use is limited to one miner's inches per acre, or 0.01 CUBIC FOOT PER SECOND (cfs), or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described, and the right shall be subject to all other conditions and limitations contained in the above described decree.

This certificate describes that portion of the water right confirmed by Certificate 86266 State Record of Water Right Certificates, REDUCED IN RATE by the provisions of an order of the Water Resources Director entered <u>DEC 18 2015</u>, approving Allocation of Conserved Water CW-46, and together with Certificate 90630, supersedes Certificate 86266.

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
