CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SCOTT L. & KATHERINE E. CAMPBELL  
83972 EASTSIDE ROAD

confirms the right to use the waters of WALLA WALLA RIVER, a tributary of Columbia River, for IRRIGATION of 15.81 ACRES.

This right was confirmed in part by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director, in Volume 12 at Page 9. The dates of priority for irrigation of 15.51 ACRES, as described below, are 1892 and 1879. The use is limited to one miner's inches per acre, or 0.389 CUBIC FOOT PER SECOND (cfs), or its equivalent in case of rotation, measured at the point of diversion from the source. This portion of the right shall be subject to all other conditions and limitations contained in the decree.

This right was also perfected in part under Permit S-1300. The date of priority for irrigation of 0.3 ACRE is July 23, 1912, as described below. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.003 CFS or its equivalent in case of rotation.

The point of diversion is located as follows:

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer. The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
