confirms the right to use the waters of SEVEN WELLS, BEING LIBRARY WELL 3, SETTLEMIER WELL 4, NAZARENE WELL 7, LEGION PARK WELL 8, DONNER WELL 9, CENTENNIAL WELL 10, AND ASTOR WAY WELL 11, in the PUDDING RIVER BASIN, for MUNICIPAL USE.

This right was perfected under Permit G-2893. The date of priority is MAY 3, 1965. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.67 cubic feet per second (CFS), further limited to no more than 0.76 CFS from LIBRARY WELL 3, 1 11 CFS from SETTLEMIER WELL 4, 1.30 CFS from DONNER WELL 9, 1.17 CFS from ASTOR WAY WELL 11, and 1.67 CFS each from NAZARENE WELL 7, LEGION PARK WELL 8, AND CENTENNIAL WELL 10, in any combination, or its equivalent in case of rotation, measured at the wells.
