confirms the right to use the waters of A WELL in the SWAN LAKE BASIN for IRRIGATING 252.2 ACRES.

This right was perfected under Permit G-9332. The date of priority is MAY 26, 1981. The right is limited to 3.15 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year. Provided further that in the event of a request for a change in point of appropriation, or repair of this well, the quantity of water allowed herein, together with any other right from this point of appropriation shall not exceed the capacity of this well at the time of perfection of this right.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
