CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DURBIN CREEK RANCH 3292 GRASS CREEK RD THERMOPOLIS WY 82443

confirms the right to use the waters of SNAKE RIVER, tributary to COLUMBIA RIVER, for IRRIGATION of 142.1 ACRES.

This right was perfected under Permit S-30095. The date of priority is OCTOBER 15, 1964. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 3.55 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion on of not to exceed 4.0 acre feet per acre for each acre irrigated during the irrigations season of each year; and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The water user shall maintain a fish screen or fish by-pass device.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm an ADDITIONAL POINT OF DIVERSION approved by an order of the Water Resources Director entered May 20, 2004, at Special Order Volume 60, Page 91, approving Transfer Application 9617, supercedes Certificate 42362, State record of Water Right Certificates.
