confirms the right to use the waters of COLUMBIA RIVER, a tributary of PACIFIC OCEAN, for WILDLIFE AND WETLANDS MAINTENANCE.

This right was perfected under Permit S-34557. The date of priority is JULY 28, 1969. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 8.21 cubic feet per second, being further limited to a diversion of not to exceed 1644.3 acre-feet, during the irrigation season of each year.

The water user shall maintain the headgate and measuring device, as needed. The water user shall report total flow figures when requested by the Watermaster. The Watermaster may operate the headgate and monitor the accuracy of the measuring device, as needed.

If the water user can not prevent water from being applied to the N $\frac{1}{2}$ N $\frac{1}{2}$, Section 13, T 5 N, R 28 E, WM, by changing the location of turnouts from the ditches, the water user shall construct a berm to prevent water from being applied to the N $\frac{1}{2}$ N $\frac{1}{2}$, Section 13, under these rights.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a CHANGE IN USE AND PLACE OF USE approved by an order of the Water Resources Director entered SEPTEMBER 24, 1998, at Special Order Volume 52, Page 836, approving Transfer Application 6930, and together with Certificate 87776, supercedes Certificate 44659, State record of Water Right Certificates.
