CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ANADROMOUS INC.
203 S COLUMBIA RIVER HWY
SAINT HELENS OR 97051

confirms the right to use the waters of FORT CREEK, a tributary of Wood River, for FISH CULTURE (a project to rear juvenile salmon in concrete ponds).

This right was perfected under Permit S-47187. The date of priority is AUGUST 27, 1982. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 44.7 CUBIC FEET PER SECOND measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users.

The point of diversion is located as follows:

The right granted shall be subject to the provisions of the Klamath Compact.

The right granted herein shall be subject to prior existing water rights.


The diversion of water from Fort Creek under the right granted herein shall be subject to maintain no measureable difference between the rate of flow of the water being diverted from Fort Creek into the facilities of the water user and the rate of flow of the water being discharged into Fort Creek from the said facilities of the water user.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484 and ORS 536.075. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 183.484, ORS 536.075 and OAR 137-004-0080, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate within three months after issuance of the certificate.

The right granted herein shall be subject to the terms and conditions of an easement executed by the applicant and recorded at page 1089, Volume 6 of the Miscellaneous Records of the Water Resources Department, and by reference made a part of this right.
