confirms the right to use the waters of A SPRING AND LOST CREEK RESERVOIR, CONSTRUCTED UNDER PERMIT R-8142, TRIBUTARIES OF ROGUE RIVER, AND ROGUE RIVER, TRIBUTARY OF PACIFIC OCEAN for DOMESTIC USE FOR TWO HOUSEHOLDS AND IRRIGATION of 5.0 ACRES.

This right was perfected under Permit S-51861. The date of priority is APRIL 18, 1989 FOR WATER FROM LIVE FLOW AND MAY 20, 1996 FOR WATER LEGALLY STORED. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.01 CUBIC FOOT PER SECOND (CFS) FROM THE SPRING, BEING 0.005 CFS FOR EACH HOUSEHOLD, WITH DEFICIENCIES IN SUPPLY TO BE MADE UP FROM THE ROGUE RIVER AND 10.0 ACRE-FEET STORED WATER ONLY, measured at the point of diversion.

The period of allowed use is OCTOBER 1 THROUGH JUNE 15 FOR DOMESTIC USE EXPANDED FOR TWO HOUSEHOLDS; FURTHER LIMITED TO 0.005 CFS JUNE 16 THROUGH SEPTEMBER 30 FOR HUMAN CONSUMPTION ONLY FOR EACH HOUSEHOLD. STORED WATER MAY BE USED FROM APRIL 1 THROUGH OCTOBER 31 EACH YEAR.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484 and ORS 536.075. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 183.484, ORS 536.075 and OAR 137-004-0080, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate within three months after issuance of the certificate.

Measurement, recording and reporting conditions:

- A. The Director will require the water user to install a meter or other suitable measuring device as approved by the Director. If the Director notifies the water user to install a meter or other measuring device, the water user shall install such device within the period stated in the notice. Such installation period shall not be less than 90 days unless special circumstances warrant a shorter installation period. Once installed, the water user shall maintain the meter or measuring device in good working order and shall allow the watermaster access to the meter or measuring device. The Director may provide an opportunity for the water user to submit alternative measuring procedures for review and approval.
- B. The Director will require the water user to keep and maintain a record of the amount (volume) of water used and may require the water user to report water use on a periodic schedule as established by the Director. In addition, the Director may require the water user to report general water use information, the periods of water use and the place and nature of use of water under the right. The Director may provide an opportunity for the water user to submit alternative reporting procedures for review and approval.

The water user shall maintain and operate fish screening, as required by the Oregon Department of Fish and Wildlife, to prevent fish from entering the diversion.

The water user shall maintain and operate a fishway at the obstruction, as required by the Oregon Department of Fish and Wildlife, to provide adequate upstream and downstream passage for fish.

The use of water under this right is subject to the terms and conditions of Contract No. 6-07-10-W1091, or a satisfactory replacement, between the Bureau of Reclamation and the water user, a copy of which is on file in the records of the Water Resources Department.

Failure to comply with any of the provisions of this right may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the right.

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
