 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ADELBERT MOORE
 ASHLAND, OR 97520

confirms the right to use the waters of NEIL CREEK, a tributary of BEAR CREEK for IRRIGATION of 340.42 acres, DOMESTIC and STOCK use.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Jackson County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 4, at Page 1. The date of priority is 1852.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 2.00 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:


