CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MCNULTY WATER PEOPLE'S UTILITY DISTRICT PO BOX 260 ST HELENS OR 97051

confirms the right to use the waters of TWO WELLS in the COLUMBIA RIVER BASIN for the purpose of QUASI-MUNICIPAL USES.

This right was perfected under Permit G-8026. The date of priority is NOVEMBER 20, 1968. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.6 CUBIC FOOT PER SECOND (CFS), further limited to 0.55 CFS from Blaha Well 1, in any combination, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

Water use measurement conditions:

- A. The water user shall maintain the totalizing flow meter(s) or, with prior approval of the Director, other suitable measuring device(s) in good working order at each point of appropriation.
- B. The water user shall allow the watermaster access to the meters or measuring devices; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.

The quantity of water diverted at the new point of appropriation, together with that diverted at the original point of appropriation, shall not exceed the quantity of water lawfully available at the original point of appropriation.

Water shall be acquired from the same aquifer as the original point of appropriation.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described; however, water may be applied to lands which are not specifically described above, provided the holder of this right complies with ORS 540.510(3).

This certificate is issued to confirm AN ADDITIONAL POINT OF APPROPRIATION approved by an order of the Water Resources Director entered APRIL 17, 2014, at Special Order Volume 92, Page 221 approving Transfer Application 11498, supersedes Certificate 65072, State record of Water Right Certificates.
