CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GLENN A WALTERS GLENN WALTERS NURSERY INC. PO BOX 280 BANKS OR 97106

confirms the right to use the waters of ROY FARM RESERVOIR, CONSTRUCTED UNDER PERMIT R-10889, TRIBUTARY TO DAIRY CREEK, AND RUNOFF, for NURSERY OPERATIONS ON 69.0 ACRES.

This right was perfected under Permit S-53552. The date of priority is MAY 20, 1998. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.73 CUBIC FEET PER SECOND FROM RUNOFF AND 41.44 ACRE-FEET FROM ROY FARM RESERVOIR or its equivalent in case of rotation, measured at the point of diversion.

The period of use is May 1 through October 1.

The points of diversion are located as follows:

The amount of water used for NURSERY OPERATIONS is limited to a diversion of 0.15 cubic foot per second per acre. For the irrigation of containerized nursery plants, the amount of water diverted is limited to ONE-FORTIETH of one cubic foot per second (or its equivalent) and 5.0 acre feet per acre per year. For the irrigation of in ground nursery plants the amount of water diverted is limited to ONE-DIGHTIETH of one cutic foot per second (or its equivalent) and 2.5 acre feet per acre per year. The use of water for NURSERY OPERATIONS may be made at anytime, during the period of allowed uses specified above, that the use is beneficial. For the irrigation of any other ctop the amount of water diverted is limited to ONE-EIGHTEITH of one cubic foot per second (or its equivalent) and 2.5 acre-feet per acre during the irrigation season of each year.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484 and ORS 536.075. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 183.484, ORS 536.075 and OAR 137-004-0080, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate within three months after issuance of the certificate.

Measurement, recording and reporting conditions:

- A. The water user shall maintain the meter or other suitable measuring device approved by the Director in good working order, shall keep a complete record of the amount of water used each month, and shall submit a report which includes the recorded water use measurements to the Department annually or more frequently as may be required by the Director. Further, the Director may require the water user to report general water-use information, including the place and nature of use of water under the right.
- B. The water user shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.

The use of water shall be limited to the water available at the point of diversion, and shall not carry with it the right to compel the continuance of the waste water.

The use may be restricted if the quality of the source stream or downstream water decreases to the point that those waters no longer meet state or federal water quality standards due to reduced flow.

The water user shall maintain and operate fish screening and fishway as required by the Oregon Department of Fish and Wildlife to prevent fish from entering the diversion.

Failure to comply with any of the provisions of this right may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the right.

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
