CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of WELL 6 AND WELL 7 IN THE COLUMBIA RIVER BASIN for FIRE PROTECTION.

This right was perfected under Permit G-2829. The date of priority is January 5, 1965. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.72 CUBIC FEET PER SECOND (CFS), FURTHER LIMITED TO 1.23 CFS FOR WELL 6 AND 1.22 CFS FOR WELL 7, in any combination, or its equivalent in case of rotation, measured at the well.

This right is limited to maintaining the fire suppression system.

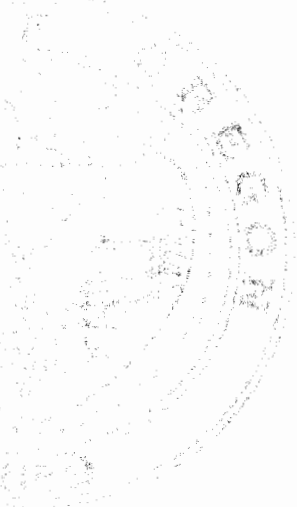

The quantity of water diverted at the new point of appropriation (well), together with the quantity diverted at the old point of appropriation, shall not exceed the quantity of water lawfully available from the original point of appropriation.

Water shall be acquired from the same aquifer as the original point of appropriation.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described.

This certificate is issued to confirm a change in PLACE OF USE AND AN ADDITIONAL POINT OF APPROPRIATION approved by an order of the Water Resources Director entered February 27, 1998, at Special Order Volume 52, Page 113, approving Transfer Application 6800, supersedes Certificate 33766, State record of Water Right Certificates.
