CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STANFIELD HUTTERIAN BRETHREN 36345 DESPAIN GULCH RD STANFIELD OR 97875

confirms the right to use the waters of COLUMBIA RIVER, tributary of PACIFIC OCEAN, for IRRIGATION of 1777.0 ACRES.

This right was perfected under Permit S-32309. The date of priority is AUGUST 15, 1967. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 44.43 CUBIC FEET PER SECOND (CFS), further limited to no more than 43.90 CFS from POD 1 for irrigation of 1756.1 acres and 0.53 CFS from POD 2 for irrigation of 20.9 acres, or its equivalent in case of rotation, measured at the point of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The quantity of water diverted at the new point of diversion shall not exceed the quantity of water lawfully available at the original point of diversion.

The water user shall operate and maintain an approved fish screen at the new point of diversion. If the Oregon Department of Fish and Wildlife (ODFW) determines that the screen is not functioning properly, and is unsuccessful in working with the water user to meet ODFW standards, ODFW may request that OWRD regulate the use of water until OWRD receives notification from ODFW that the fish screen is functioning properly.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use herein described and is subject to minimum flows established by the Water Policy Review Board with an effective date prior to this right.

This certificate is issued to confirm changes in PLACE OF USE AND POINT OF DIVERSION approved by an order of the Water Resources Director entered JANUARY 29, 2015, at Special Order Volume 93, Page 1210, approving Transfer Application 11770, supersedes Certificate 52222, State record of Water Right Certificates.
