CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STANFIELD HUTTERIAN BRETHERN  
 36345 DESPAIN GULCH RD  
 STANFIELD OR 97875

confirms the right to use the waters of COLUMBIA RIVER, tributary of PACIFIC OCEAN, for IRRIGATION of 195.8 ACRES.

This right was perfected under Permit S-48119. The date of priority is SEPTEMBER 23, 1983. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 4.9 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under this right, and to which such right is appurtenant, is as follows:

The right is subject to minimum flows established by the Water Policy Review Board with an effective date prior to this right.

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered JANUARY 29, 2015, at Special Order Volume 93, Page 1210, approving Transfer Application 11770, supersedes Certificate 64411, State record of Water Right Certificates.
