## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WOLFE HEREFORD RANCH, WTK INC. ATTN: STEPHEN WOLFE 81554 E HWY 82 WALLOWA OR 97885

confirms the right to the use of waters of LOSTINE RIVER (AKA SOUTH FORK OF THE WALLOWA RIVER), a tributary of WALLOWA RIVER for IRRIGATION OF 25.0 ACRES AND STOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Wallowa County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 5, at Page 175. The dates of priority are 1879 FOR 24.0 ACRES AND 1881 FOR 1.0 ACRE.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1½ acre feet per acre during any period of 30 days prior to July 31<sup>st</sup> of each year, and thereafter not to exceed 1 acre foot per acre during the entire remainder of the irrigation season, if available at the point of diversions, or its equivalent in case of rotation, measured at the points of diversion from the source.

The point of diversion is located as follows:

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.

Water shall be acquired from the same surface water source as the original point of diversion.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described, and is subject to all other conditions and limitations contained in the decree.

This certificate is issued to confirm a change in PLACE OF USE and POINT OF DIVERSION approved by an order of the Water Resources Director entered FEBRUARY 22, 2005, at Special Order Volume 63, Page 304, approving Transfer Application 8221, and supercedes Certificate 3061, State record of Water Right Certificates.
