The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This certificate describes that portion of the water right confirmed by Certificate 1668, State Record of Water Right Certificates, NOT modified by the provisions of two Final Orders of the Water Resources Director entered December 13, 2007, approving Transfer Application T-10416 and August 18, 2009, approving Transfer Application T-10748. This certificate corrects the amount of acres described in the place of use from partial cancellations contained in the aforementioned final orders and supersedes Certificates 83678 and 85741.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
