CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LHR, LTD 71105 HOLMES RD SISTERS, OR 97759

confirms the right to use the waters of a WELL in the DESCHUTES BASIN for IRRIGATION of 38.3 ACRES.

This right was perfected under Permit G-8566. The date of priority is JULY 31, 1978. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.41 CUBIC FOOT PER SECOND (CFS), or its equivalent in case of rotation, measured at the well, provided further that in the event of a request for a change in point of appropriation, an additional point of appropriation or repair of this well, the quantity of water allowed herein together with any other right from this point of appropriation shall not exceed the capacity of this well at the time of perfection of this right.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works shall be equipped with a usable access port, and may also include an air line and pressure gauge adequate to determine water level elevation in the well at all times. When required by the Department, the water user shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

This certificate is issued to correct a scrivener's error in the amount of cfs described on Certificate 89811 which was superseded by 90596 which also incorrectly described the amount of cfs. This Certificate supersedes Certificate 90596, and describes the portion of water right Certificate 76811, NOT modified by the provisions of an order of the Water Resources Director entered March 6, 2015, and recorded at Volume 95, Page 191-195, approving Transfer Application T-11879, and an order of the Water Resources Director entered August 4, 2015, and recorded at Volume 96, Page 743-746, approving Transfer Application T-11913.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described.
