confirms the right to use the waters of HALE WELL 5 within the STAGE GULCH BASIN, for IRRIGATION of 208.7 ACRES AND SUPPLEMENTAL IRRIGATION OF 61.3 ACRES.

This right was perfected under Permit G-4969. The date of priority is JUNE 8, 1971. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 2.51 CUBIC FEET PER SECOND (CFS), BEING 1.94 CFS for IRRIGATION, AND 0.57 CFS for SUPPLEMENTAL IRRIGATION or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year. The use shall conform to any reasonable rotation system ordered by the proper state officer.

Water shall be acquired from the same aquifer as the original point of appropriation.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in PLACE OF USE AND AN ADDITIONAL POINT OF APPROPRIATION approved by an order of the Water Resources Director entered May 31, 2003, at Special Order Volume 57, Page 893, approving Transfer Application 6787, and together with Certificate 85124, supercedes Certificate 74897, State record of Water Right Certificates.
