## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of LOST CREEK AND LOST LAKE RESERVOIR, CONSTRUCTED UNDER PERMIT R-427, tributaries to SOUTH FORK LITTLE BUTTE CREEK for IRRIGATION of 9.86 ACRES.

This right was perfected under Permit 3733. The date of priority is FEBRUARY 16, 1918. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.112 CUBIC FOOT PER SECOND (CFS); BEING 0.11 CFS FROM POD 1 AND 0.002 CFS FROM POD 2, if available at the original point of diversion: Tyrrell East Side Ditch located in SW ¼ NW ¼ section 22, T 37 S, R 2 E, WM; North 35 Degree's East, 660 feet from the W ¼ Corner, Section 22, or its equivalent in case of rotation, measured at the points of diversion.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated during the irrigation season of each year.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
