CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of WELL #2, in the FORT ROCK BASIN for IRRIGATION of 35.0 ACRES.

This right, as evidenced by a PORTION of Certificate 55098, was perfected under Permit G-9065. The date of priority is JULY 2, 1980. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.44 cubic foot per second, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use is as follows:

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Water shall be acquired from the same aquifer as the original point of appropriation.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in PLACE OF USE AND POINTS OF APPROPRIATION approved by an order of the Water Resources Director entered October 8, 2001, at Special Order Volume 55, Page 1115, approving Transfer Application 8020, and together with Certificate 77741, supersedes Certificate 55098, State Record of Water Right Certificates.
