CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of NORTH UMPQUA RIVER, a tributary to the UMPQUA RIVER for DOMESTIC USE FOR ONE HOUSEHOLD, IRRIGATION OF 2.2 ACRES AND LIVESTOCK WATER.

This right was perfected under Permit S-43279. The date of priority is MAY 18, 1978. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.0356 CUBIC FOOT PER SECOND (CFS), BEING 0.005 CFS FOR HOUSEHOLD USE, 0.0026 CFS FOR STOCKWATER, AND 0.028 CFS FOR IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acrefeet per acre for each acre irrigated during the irrigation season of each year.
