CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

FARMERS WATER DITCH CO.
JOSEPH, OR 97846

confirms the right to use the waters of the WALLOWA RIVER, a tributary to the GRANDE RONDE RIVER FOR IRRIGATION OF 4782.0 ACRES, LIVESTOCK AND DOMESTIC USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Wallowa County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 5, at Pages 163, 164, 165 and 166. The date of priority is 1900.

The amount of water to which this right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.5 acre feet per acre during any period of 30 days prior to July 31st of each year, and thereafter not to exceed 1.0 acre foot per acre during the entire remainder of the irrigation season; and said right shall be subject to all other conditions and limitations contained in said decree.

The point of diversion is the Farmers Ditch.

A description of the place of use to which this right is appurtenant is as follows:
