confirms the right to use the waters of RHEA CREEK, tributary to WILLOW CREEK for IRRIGATION of 93.2 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Morrow County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 1, at Page 73. The dates of priority are 1874 for 73.7 ACRES and 1879 for 19.5 ACRES.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.55 CUBIC FEET PER SECOND (CFS), being 1.23 CFS as of date 1874 and 0.32 CFS as of date 1879, measured at the point of diversion.

The quantity of water diverted at the new points of diversion, together with that diverted at the old points of diversion, shall not exceed the quantity of water lawfully available from the original point(s) of diversion.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

When required by the Department, the water user shall install and maintain headgates, in-line flow meters, weirs, or other suitable devices for measuring and recording the quantity of water diverted. The types and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Water shall be acquired from the same surface source as the original point of diversion.

The water user shall maintain a fish screen or fish by-pass device.

The right to the use of the water for the above purpose is restricted to beneficial use on place of use described, and is subject to all other conditions and limitations contained in the decree.

This certificate is issued to confirm ADDITIONAL POINTS OF DIVERSION approved by an order of the Water Resources Director entered November 19, 2001, at Special Order Volume 55, Page 1220, approving Transfer Application 6761, and together with Certificate 78513, supercedes Certificate 213, State Record of Water Right Certificates.
