CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MR. AND MRS. DENNIS R. HARMON 6164 NEW HOPE RD GRANTS PASS OR 97527

confirms the right to use the waters of APPLEGATE RIVER, tributary to ROGUE RIVER, for IRRIGATION of 32.3 ACRES.

This right was perfected under Permit E-40. The date of priority is MARCH 2, 1910. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.40 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic for per second (or its equivalent) for each acre irrigated during the irrigation season of each year.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The right to use the water for the above purpose is restricted to beneficial use on the land or place of use described.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered May 10, 1994, at Special Order Volume 48, Page 180, approving Transfer Application 6944, and together with Certificate 68378, supercedes Certificate 48536, State record of Water Right Certificates.
