confirms the right to use the waters of BIG BUTTER CREEK, a tributary of the UMATILLA RIVER, for IRRIGATION of 9.67 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for UMATILLA County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 3, at Page 250. The date of priority are 1880 AND 1890.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.19 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The use shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use is as follows:

The quantity of water diverted at the new point of diversion from Butter Creek, shall not exceed the quantity of water lawfully available from the original point of diversion described as follows:

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.


The water user shall maintain an in-line flow meter or other suitable device for measuring and recording the quantity of water used.

Water shall be acquired from the same surface source as the original point of diversion.

The right to the use of the water for the above purpose is restricted to beneficial use on place of use described, and is subject to all other conditions and limitations contained in said decree.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered JUNE 14, 2004, at Special Order Volume 60, Page 307, approving Transfer Application 9296, and together with Certificate 80768, supercedes Certificate 80067, State Record of Water Right Certificates.
