CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

PEYRON RANCH INC.
42659 SUNNYSLOPE RD
BAKER CITY OR 97814

confirms the right to use the waters of POWDER RIVER, a tributary of the SNAKE RIVER, for IRRIGATION of 24.9 ACRES.

This right was perfected under Permit S-32989. The date of priority is SEPTEMBER 5, 1967. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.62 CUBIC FOOT PER SECOND, if available at the authorized point of diversion: SMITH DITCH – NW1/4 NE1/4, SECTION 19, T 10 S, R 40 E, W.M.; 6150 FEET SOUTH AND 1920 FEET WEST FROM NE CORNER OF SECTION 18, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

9 S	40 E	WM	9	SW NW	CORRELL DITCH - 50 FEET NORTH AND 2560 FEET WEST FROM C1/4 CORNER, SECTION 9

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 1/2 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use is as follows:

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable measuring device for measuring and recording the quantity of water diverted.

Water shall be acquired from the same surface water source as the original point of diversion as follows.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered November 25, 2003, at Special Order Volume 58, Page 205, approving Transfer Application 7791, supercedes Certificate 73533, State record of Water Right Certificates.
