CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

W. R. CAMPBELL, ET. AL. BLY, OREGON

confirms the right to use the waters of Stored water in Campbell Reservoir, on an unnamed dry wash, constructed under App. No. R-17044, Per. No. R-716, a tributary of South Fork Sprague River for IRRIGATION AND SUPPLEMENTAL IRRIGATION of 1473.5 ACRES.

This right was perfected under Permit S-13015. The date of priority is AUGUST 17, 1937. The amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 22.59 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated prior to June 15, and ONE-EIGHTIETH of one cubic foot per second or its equivalent for each acre irrigated after June 15, of each year and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season from March 1, to October 1, and shall be further limited to a total diversion of not to exceed 22.59 second-feet. And shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
