confirms the right to use the waters of MINAM LAKE RESERVIOR, CONSTRUCTED UNDER PERMIT R-396, CERTIFICATE NO. 4937, a tributary of MINAM LAKE, for SUPPLEMENTAL IRRIGATION of 14.6 ACRES.

This right was perfected under Permit S-3271. The date of priority is MAY 29, 1916. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.078 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent in case of rotation.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Water shall be acquired from the same surface water source as the original point of diversion.

The appropriator shall record and report total flow figures when requested by the Watermaster.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
