CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MIDDLE FORK IRRIGATION DISTRICT
P.O. BOX 291
PARKDALE, OREGON 97041

confirms the right to use the waters of CLEAR CREEK AND COE CREEK, tributary to MIDDLE FORK HOOD RIVER for FROST PROTECTION ON 365.21 ACRES.

This right was perfected under Permit S-51370.

The date of priority is JUNE 1, 1987.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 35.84 Cubic Feet per Second (CFS), being 15.0 CFS from COE CREEK and 20.84 CFS from CLEAR CREEK, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located:

CLEAR CREEK: 520 FEET SOUTH and 2500 FEET WEST from the NE CORNER, SECTION 27, being within the NW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 27, Township 1 South, Range 9 East, W.M.

COE CREEK: 2598 FEET SOUTH and 945 FEET WEST from the NE CORNER, SECTION 27, being within the SE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 27, Township 1 South, Range 9 East, W.M.

The amount of water used for temperature control together with the amount secured under any other prior right existing for the same lands is limited to 0.15 CFS per acre.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484 and ORS 536.075. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 183.484, ORS 536.075 and OAR 137-004-0080, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate within three months after issuance of the certificate.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.


